# B. Atlanta Eagle Closing Party Post-Mortem

- Merlin ONYX expressed his displeasure with the brothers' attendance.
- Merlin ONYX wants the brothers to examine their commitment ONYX-SE.
- Merlin ONYX opened the floor for comments and questions.
  - Hannibal ONYX explained that he didn't attend the event because of his
    negative interaction with the Atlanta Eagle's staff and its management's lack of
    concern for said interaction.
  - Twilight ONYX explained his reasons for not attending the event as well, which included an acknowledgement of racial tension and insensitivity at the Atlanta Eagle.
  - Merlin ONYX encouraged the brothers to speak up about any racially / culturally insensitive experiences when they occur.
  - Merlin ONYX encouraged the brothers to present options and suggestions for a new home bar before there's any discussion or voting on whether or not to leave the Atlanta Eagle.
  - Hannibal ONYX suggested that there be communication with the Atlanta Eagle regarding the racism and bigotry toward ONYX-SE and other POC and how it can be rectified.
